Set Compliance Schedules

Step 1: Add Properties to FilterSync

Get Started by Importing Your Portfolio

- Option 1: Bulk Upload
Upload your property list via spreadsheet (recommended for portfolios). Include:
 - Property address
 - Lease start and end dates
 - Tenant contact info (especially mobile numbers)
- Option 2: Manual Entry
- Add properties one at a time if you prefer a more granular approach.

Tip: FilterSync charges only for properties that are activated, so you can import your entire portfolio and activate them as needed.

Step 2: Set Filter Change Schedules

Choose the Frequency That Works Best for You

- Default Frequency: Choose a default filter change frequency for all properties (e.g., every 30, 60, or 90 days).
- Custom Frequency: Customize filter schedules for individual properties if needed based on tenant needs or property requirements.

Tip: Set the default to streamline the process for most properties and adjust only where necessary.

Set Compliance Schedules

Step 3: Enter Filter Sizes (Not required but recommended)

Keep Track of Filter Sizes for Your Records

- Add Filter Sizes: If available, enter each property's air filter size.
- Tenants Won't See This Info: Filter sizes are stored for your records and are used to ensure compliance, but tenants won't see or be required to enter this information.

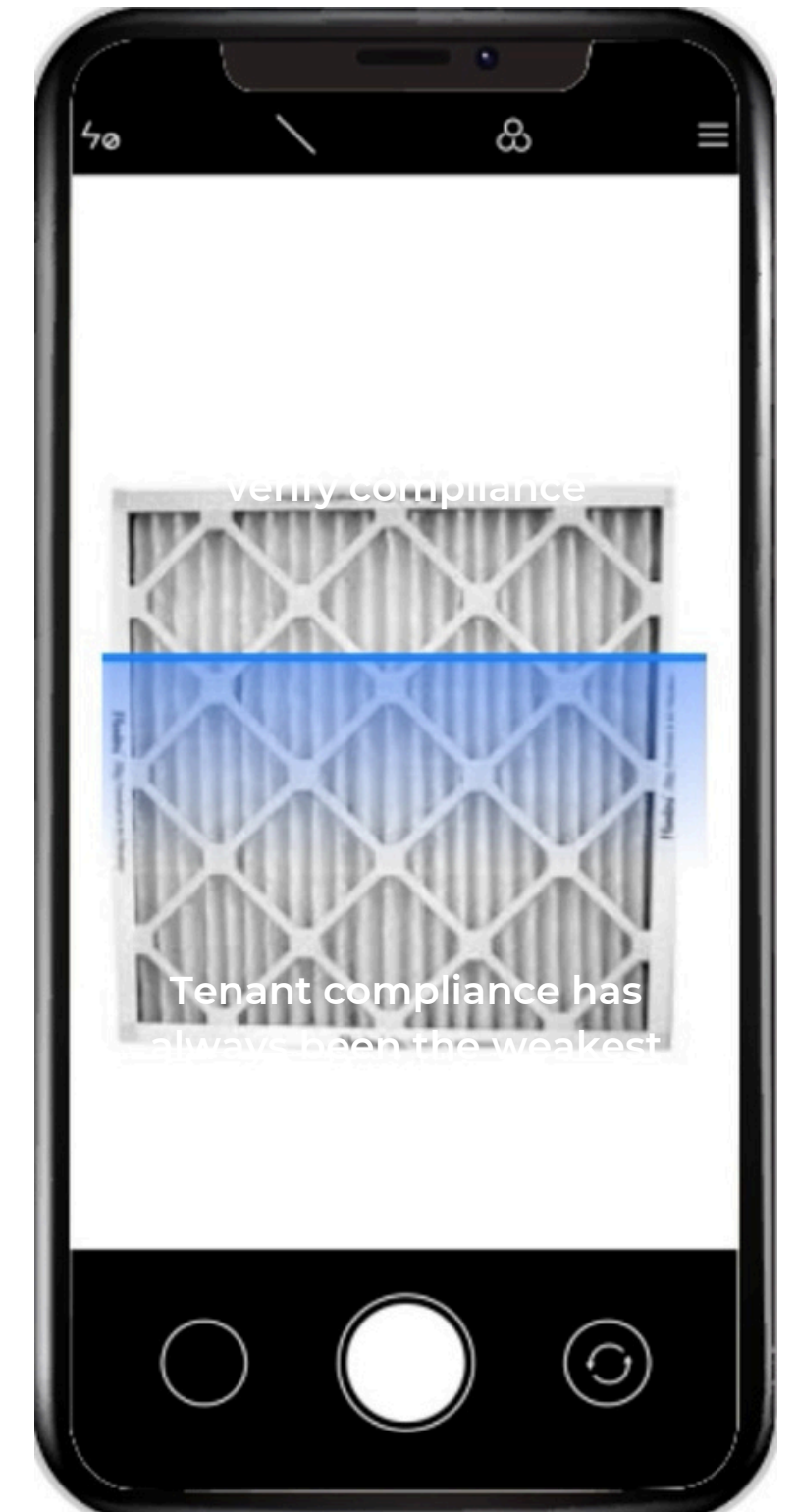
Tip: This step is useful for you as a reference but isn't required for tenant participation.

Step 4: Set Grace Period for Compliance

Define How Much Time Tenants Have to Comply

- Grace Period Settings: Choose how many days you want to allow tenants to submit their filter change photo before they receive a final notice.
- Final Message: After the grace period, tenants will receive a message notifying them that a technician will be dispatched at their expense.

Tip: A typical grace period ranges from 1 to 7 days depending on your preferences for compliance.

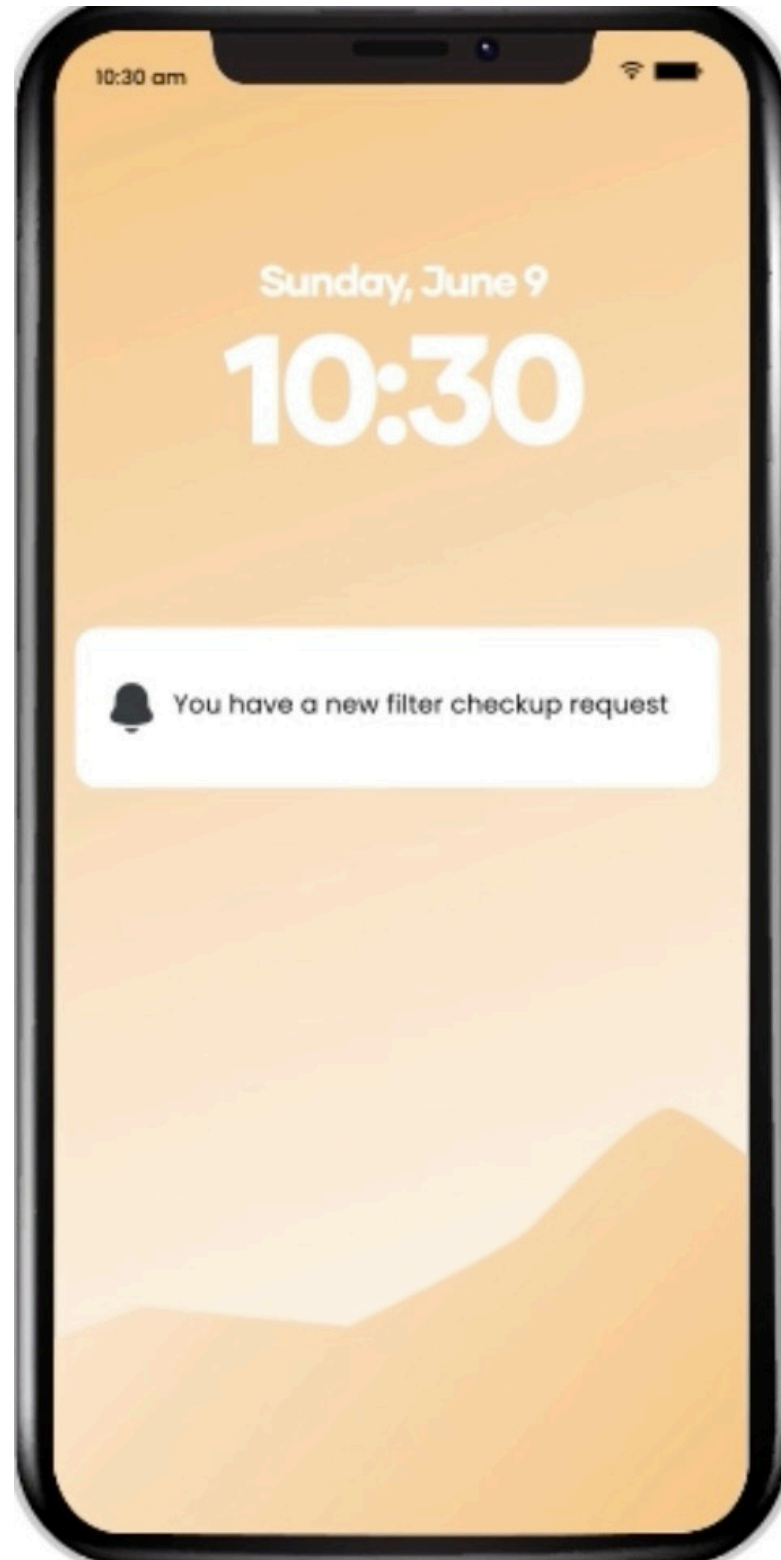
Step 5: Activate Properties

Activate Properties and Start Tenant Engagement

- Activate Each Property: Once a property is set up, activate it in FilterSync.
- Tenant Welcome Message: Upon activation, tenants will receive a welcome message, including an introductory explainer video and instructions for submitting photos.
 - New Managed Property: Tenant receives a request for a baseline image of the HVAC filter.
 - Turnover: During tenant turnover, set the property to initiate the verification process.

Tip: Use this step as an opportunity to educate tenants upfront and create a seamless experience.
